DATE: RE:	Public Information Officers April 28, 2020 eLearning Plans for 2020-2021

Many challenges are ahead, but we have an opportunity to work collaboratively to reimagine what is possible for students in South Carolina. Recently, the Education Oversight Committee (EOC) completed and presented a review of the second year of eLearning, a pilot program for alternative methods of instruction for make-up days pursuant to Proviso 1A.83 of the 2019-20 General Appropriation Act. Fifteen school districts have been involved in the pilot project covering two school years. The EOC will work collaboratively with the South Carolina Department of Education (SCDE) in an effort to bring resources (both financial and human) together to support the delivery of instruction via technology across the state in 2020-21 for Cohort 3 should the approved state budget for 2020-21 include this directive.

The application process for Year 3 of eLearning will be as follows:

- Beginning on May 11, 2020, a district may submit its application via bit.ly/ eLearning2020Cohort3 to be considered for Cohort 3 of eLearning. The application process for Cohort 3 of eLearning will close on May 22, 2020. Districts will be notified of any decision by May 29, 2020.
- In addition to the eLearning Cohort 3, a **Readiness Cohort** will also be established. The Readiness Cohort is intended to support districts who are interested in harnessing the potential of instructional technology but who may lack some foundational or technical requirements for full implementation of eLearning. Districts accepted into the Readiness Cohort will not be able to use eLearning to make-up days in the Fall 2020 semester, but if capability is adequately addressed as determined by EOC and SCDE, the district may petition to be included in the eLearning Cohorts in the Spring of 2021. The application for the Readiness Cohort will open on May 11, 2020 via the link above and close on May 22, 2020. Districts will be notified of any decision by May 29, 2020.
- In addition to those selected by application in the process described above, Cohort 3 will include districts from eLearning Cohorts 1 and 2 as well as those selected through a collaborative review by EOC and SCDE staff of district applications for remote learning via technology in response to COVID-19 school closure. The list of these districts who are automatically cleared for inclusion in Cohort 3 is included at the end of this letter.

Action Items and Timeline

- May 11- 22
 - Receive applications, review, and identify additional districts for Cohort 3 (plus 24 identified to this point)
 - Receive requests to engage in the Readiness Cohort
- May 29
 - Notify *all* districts regarding status in Cohort 3, Readiness Cohort, and regional groups
 - Share sample IT bundles, LMS implementation suggestions, share PD schedule for teachers (include multiple resources SCETV, State Library, SREB, other districts, SDE)
- June
 - Continuum to communicate with districts; share suggestions/models
 - Offer site visits to lead districts for Regional Geographical Clusters (pending coronavirus situation)
 - Continue to share sample IT bundles, LMS implementation suggestions, share PD schedule for teachers (include multiple resources SCETV, State Library, SREB, other districts, SDE)
 - Survey Needs Groups identified, and professional development sessions coordinated
- July (tentatively Thursday, July 30)
 - Host one statewide meeting for all 3 Cohorts (SDE and EOC) (10-12:30)
 - Meet with Cohort Readiness (SDE and EOC reps facilitate) (10-12:30)
 - Break-out to Region groups and Cohort Readiness (1:30-3:00)
- August November
 - Regional groups meet with selected Regional Leads (Cohort 3 required Cohort Readiness as optional)
 - Meet with Cohort Readiness (SCSDE and EOC reps facilitate)
 - Site visits to Regional group meetings
 - Site visits to each district in Readiness Cohort
- February EOC Meeting
 - Preliminary Report on Cohort 3 and Regional Cohort eLearning Model submitted to SBE and EOC (require per Proviso)
 - Preliminary Report on Cohort Readiness submitted
 - Continue to collect data on eLearning days used

- April EOC Meeting
 - Final report on Cohort 3, the Regional Cohort eLearning Model; Readiness Cohort
 - SDE submits recommendations for continuation and its facilitation of eLearning
