Dear Ms. Barton,

Coastal Christian Preparatory School, located in Mt. Pleasant, SC is an independent school that offers a specially designed program or learning resource center to provide necessary accommodations based on the needs of exceptional children. It also provides onsite educational services and supports to meet the needs of exceptional needs students.

Included in the accommodations provided by Coastal Christian Preparatory School is our GRACE program. The GRACE program provides an individualized learning environment for students who struggle academically, socially, or emotionally. The GRACE program instructors collaborate with classroom teachers, parents and other professionals to meet each student's individual needs and work to implement essential accommodation plans. Through this close partnership, the GRACE instructors are able to nurture and support these children academically, socially, and emotionally to help them learn to their potential.

The GRACE program is delivered during school hours both in and out of the classroom. There are different levels of service, involving differing amounts of individualized time with a GRACE instructor. An individualized plan is drawn up for each child, following a review of individual needs. Areas to be addressed include, but are not limited to:

• General academic support, including specific subject areas, organizational skills, time management

- Test preparation, review and test taking strategies
- Individual accommodation plan design and management
- Coordination between teachers, outside professionals and parents

More specific examples of accommodations provided to students through the GRACE program may include:

- 1-1 instruction both inside and outside the classroom
- Academic support
- Individualized instruction
- Learning plans
- Small group testing
- Oral testing

- Use of calculators on tests or classwork
- Reduced homework and classwork
- Reduced number of problems on tests and quizzes
- Test preparation strategies
- Organization and planning assistance
- Spelling accommodations
- Handwriting accommodations
- Additional time allotted for tests and classwork
- Classroom notes provided to student from teacher
- Preferential seating
- Use of typing
- Use of "bouncy ball" seating
- Use of balance boards
- Use of silly putty for tactile learning
- Quiet room for students suffering from anxiety or emotional disturbances
- Reviewing and re-teaching skills
- Permitting authorized adult "shadow" during the day
- Permitting authorized trained assistants and therapists in the classroom to work with student

Each child's specific needs are evaluated through a collaboration with the GRACE instructors, classroom teachers, parents and other professionals to create a personalized accommodations plan. The plan is reviewed and adjusted as necessary throughout the year based on the needs of each student in the program.

The GRACE program, and the accommodations mentioned above, are specific to evaluated students with exceptional needs.

Annually, the Education Oversight Committee shall issue a report to the General Assembly documenting the impact of the Educational Credit for Exceptional Needs Children Program on student achievement. In addition, the report must include information on individual schools if at least fifty-one percent of the total enrolled students in the private school participated in the Educational Credit for Exceptional Needs Children Program in the prior school year. The report must be according to each participating private school, and for participating students, in which there are at least thirty participating students who have scores for tests administered. If the Education Oversight Committee determines that the thirty participating-student cell size may be reduced without disclosing personally identifiable information of a participating student, the Education Oversight Committee may reduce the participating-student cell size, but the cell size may not be reduced to less than ten participating students. Section 12-6-3790(E)(6)

Therefore, schools applying for participation in the ECENC Program for the first time in 2018-19 must provide the following to the EOC by **December 31, 2018**:

**School-level assessment results** for school year 2017-18 on national achievement tests for all grades tested in the school and for each grade with at least 10 students tested. Information should be provided for English language arts (reading) and mathematics achievement of students in the grade. Examples include: *TerraNova, Stanford 10, Iowa Test of Basic Skills, etc.* For grades 9-12, the school may provide average PSAT, SAT, ACT, or other scores as appropriate. Since your school did not participate in the ECENC program in the prior school year, 2017-18, you are **not** required to submit **individual student test scores** on national achievement tests.

For schools that specifically exist to meet the needs of only exceptional needs students with documented disabilities, the EOC will work with the schools to provide information (including formative assessments, portfolios, etc.) that document the students' academic and social development.
