Hidden Treasure Christian School Summary of Services Provided

Hidden Treasure Christian School (HTCS) is a school specifically existing to meet the needs of only exceptional needs students with documented disabilities.

Categorically, HTCS serves students who are learning disabled, slow learners, educable mentally disabled, trainable mentally disabled, severely mentally disabled, physically disabled, have emotional disorders, attention deficit disorders, autism, and other health impairments.

HTCS currently serves students with the following diagnoses: autism, Asperger syndrome, Down syndrome, developmental delays, verbally impaired, seizures, anxiety disorders, intellectual disabilities, genetic alterations, sensory processing disorders, emotional disorders, Shwachman-Diamond syndrome, ADHD, Fragile X syndrome, and other health impairments.

HTCS offers a vocational training program, physical education program, fine arts program, and community involvement programs.

In addition, HTCS provides a physical therapy program to provide physically disabled children with the rehabilitative exercises necessary to establish and maintain the maximum range of motion and flexibility, an occupational therapy program to provide students with needed training in the use of special augmentative devices and help them become functionally independent, and a speech therapy program to provide students with proper procedures in pronunciation and articulation.

INDEPENDENT ACCOUNTANTS' REPORT ON APPLYING AGREED-UPON PROCEDURES

We have performed the procedures enumerated below, which were agreed to by the management of Hidden Treasure Christian School ("the School"), on its compliance with certain requirements of the SC Education Oversight Committee in its determination of the School's eligibility to participate in the Educational Credit for Exceptional Needs Children Program for the year ended June 30, 2018, in the areas addressed. The School's management is responsible for compliance with the requirements of the Educational Credit for Exceptional Needs Children Program. The sufficiency of these procedures is solely the responsibility of the specified parties in this report. Consequently, we make no representation regarding the sufficiency of the procedures described below either for the purpose for which this report has been requested or for any other purpose.

Specifically, for purposes of this report, we have performed the following procedures and noted the indicated findings:

- Ascertained that Hidden Treasure Christian School can document and verify that all grants received under the Educational Credit for Exceptional Needs Children Program were for eligible children who were enrolled and attended School. We did not determine eligibility regarding disability.
 - We obtained documentation to verify that grants received under the Educational Credit for Exceptional Needs Children Program were for eligible children enrolled to attend the School. We noted no findings as a result of our procedures.
- 2. Verified the total amount of each grant per child from each scholarship funding organization (SFO).
 - a. We compared the total of grants received for each child to the amount(s) disbursed from each scholarship funding organization (the "SFO"). We noted no findings as a result of our procedures.
- 3. Verified that no grant exceeded \$11,000 during 2017-18 school year.
 - a. We obtained documentation to verify that no individual student's grant exceeded \$11,000 for the 2017-18 school year. We noted no findings as a result of our procedures.
- 4. If applicable, we verified that the School returned to the SFO a prorated amount of a student's grant if a student withdrew from the School during the school year.
 - a. We verified that the School returned to the SFO a prorated amount of a student's grant if a student withdrew from the School during the school year. We noted no findings as a result of our procedures.

- 5. Verified that the total amount of each grant was used for tuition which is defined as "the total amount of money charged for the cost of a qualifying student to attend an independent school including, but not limited to, fees for attending the school and school-related transportation."
 - a. We obtained documentation that each grant was used for tuition. We noted no findings as a result of our procedures.

The engagement to apply the Agreed-Upon Procedures was performed in accordance with the standards established by the American Institute of Certified Public Accountants. We were not engaged to, and did not, perform an examiniation or review, the objective of which would be the expression of an opinion or conclusion, respectively, on the School's compliance with certain requirements of the South Carolina Educational Credit for Exceptional Needs Children Program, as recommended by the South Carolina Education Oversight Committee. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the use of the School's management and applicable State agencies, and should not be used by anyone other than these specified parties. This restriction is not intended to limit distribution of this report, which is a matter of public record.
