Coastal Christian Preparatory School, located in Mt. Pleasant, SC is an independent school that offers a specially designed program or learning resource center to provide necessary accommodations based on the needs of exceptional children. It also provides onsite educational services and supports to meet the needs of exceptional needs students.

Included in the accommodations made available through Coastal Christian Preparatory School (CCPS) are our onsite GRACE and DRIVEN programs and our partnership with The Orton-Gillingham Center of Charleston (OGCC).

The CCPS GRACE and DRIVEN programs provide an individualized learning environment for students who struggle academically, socially, or emotionally. These program instructors collaborate with classroom teachers, parents and other professionals to meet each student's individual needs and work to implement essential accommodation plans. Through this close partnership, the GRACE and DRIVEN instructors are able to nurture and support these children academically, socially, and emotionally to help them learn to their potential.

The GRACE program is delivered during school hours both in and out of the classroom. There are different levels of service, involving differing amounts of individualized time with a GRACE instructor. An individualized plan is drawn up for each child, following a review of individual needs. Areas to be addressed include, but are not limited to:

- General academic support, including specific subject areas, organizational skills, time management
- Test preparation, review and test taking strategies
- Individual accommodation plan design and management
- Coordination between teachers, outside professionals and parents

More specific examples of accommodations provided to students through the GRACE program may include:

1-1 instruction both inside and outside the classroom  
Academic support through individualized instruction and learning plans

- Small group testing, oral testing, extended time on testing
- Use of calculators on tests or classwork
- Reduced homework, classwork, and number of problems on tests and quizzes
- Organization and planning assistance and test preparation strategies
- Spelling and handwriting accommodations
- Use of computers or Chromebooks
- Classroom notes provided to student from teacher
- Preferential seating
- Use of “bouncy ball” seating or balance boards for movement
- Use of silly putty for tactile learning
- Quiet room for students suffering from anxiety or emotional disturbances
- Reviewing and re-teaching skills individually or in small-group
- Permitting authorized adult “shadow” during the day
- Permitting authorized trained assistants and therapists in the classroom to work with student

Each child’s specific needs are evaluated through a collaboration with the GRACE instructors, classroom teachers, parents and other professionals to create a personalized accommodations plan. The plan is reviewed and adjusted as necessary throughout the year based on the needs of each student in the program.

The GRACE program, and the accommodations mentioned above, are specific to students who have been evaluated and have demonstrated exceptional needs.

The DRIVEN Program meets with students and their families on campus after school hours in order to develop plans and strategies to help students overcome behavioral challenges and provide emotional support.

Coastal Christian has also partnered with The Orton-Gillingham Center of Charleston (OGCC), which is housed on our Coastal Christian campus. OGCC uses the Orton-Gillingham approach to focus on servicing dyslexic students specifically in the areas of reading and early intervention. CCPS students receive this service onsite during the day in cooperation with the OGCC, the students’ parents, our GRACE program coordinator, administrative staff, and the respective classroom teachers.
